MAKING A SALE

Gtext Land/ Gtext Homes

When a client is ready to buy a land or property either physically or virtually, there is a process. In some cases, clients buy immediately after site inspection or during inspection whilst others buy when they see videos of the property or just when they see the flier. However it may be, we would need their information, which is retrieved from a subscription form they have to fill during purchase. This is the document to confirm their interest in purchasing a land or property by giving their contact details and information on the property they want to buy. The Subscription form consists of columns for personal details, passport, and information of properties they are purchasing, terms and conditions and FAQ. The form can be printed or sent electronically.

COMMISSION

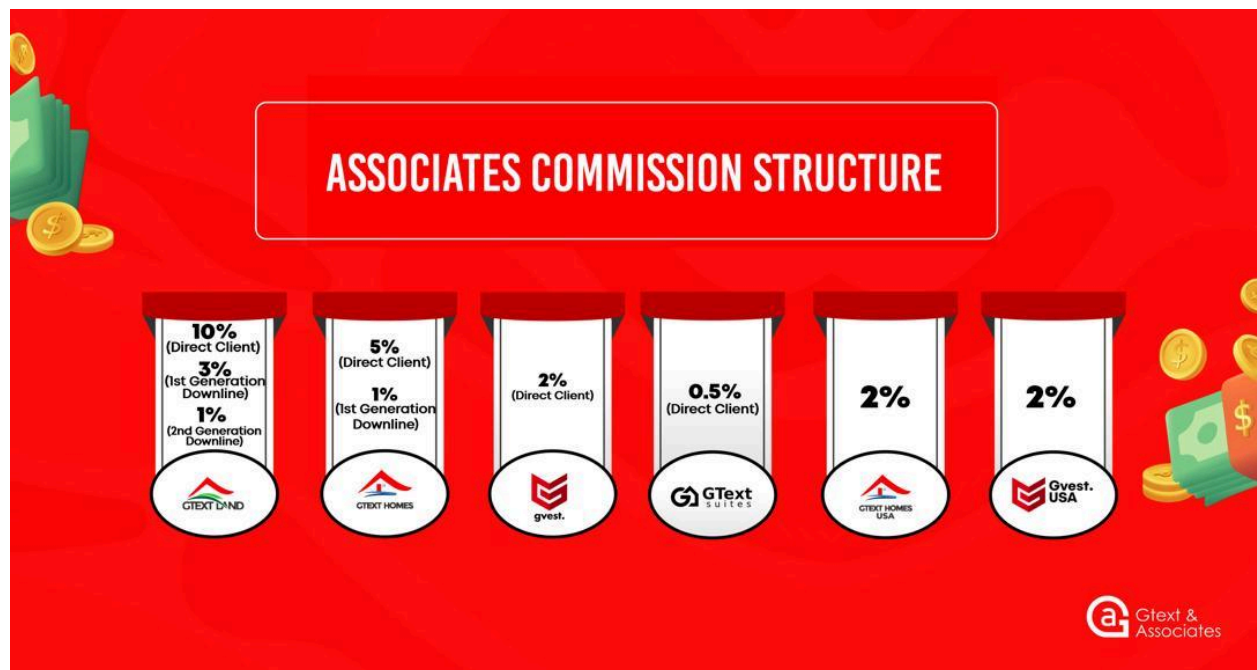
After making a sale, the next process is to send in all the transaction details which include the payment receipt for confirmation, subscription form, clients means of identification (ID card & passport). Upon submission, you will be required to fill a commission form and submit it. When

received, your payment will be processed within 3-5 working days under normal circumstances. However, commission is only processed when payment is confirmed and client's documents have been submitted.

Refer to the **Commission Structure breakdown** of each of our products for better understanding:



As an Associate with Gtext, you have the opportunity to earn commissions not just from your direct sales but also from the sales made by your downlines when you register associates under you.

Below is a breakdown of the commission structure for different product categories:

1) **Gtext Lands (Nigeria)**

Direct Commission: If you (Realtor A) make a direct sale of any Gtext land, you earn 10% commission on that sale.

Indirect Commission (1st Generation Downline): If you register an associate (Realtor B), and B makes a sale on any Gtext land, you earn 3% commission on B's sale.

Indirect Commission (2nd Generation Downline): If B registers another associate (Realtor C), and C makes a sale on any Gtext land, you earn 1% commission on C's sale.

② Gtext Homes (Nigeria)

Direct Commission: If you (Realtor A) make a direct sale of any Gtext housing unit, you earn 5% commission on that sale.

Indirect Commission (1st Generation Downline): If you register an associate (Realtor B), and B makes a sale on any Gtext housing unit, you earn 1% commission on B's sale.

③ Gvest Investment (Nigeria & USA)

Direct Commission: If you (Realtor A) make a direct sale of any Gvest investment in either Nigeria or the USA, you earn 2% commission on that sale.

④ Gtext Suites (Dubai & Nigeria)

Direct Commission: If you (Realtor A) make a direct sale of any Gtext Suites Housing Projects, you earn 0.5% commission on that sale.

⑤ Gtext USA (Lands & Homes)

Direct Commission: If you (Realtor A) make a direct sale of any Gtext land or home in the USA, you earn 2% commission on that sale.

This commission structure gives you a great opportunity to build wealth through real estate sales and referrals. Maximize your earnings by building a strong network of realtors under you!

Example Scenario:

If you sold a ₦10,000,000 land plot (Nigeria):

- You earn ₦1,000,000 (10%)

If your downline Realtor B sold it:

- You earn ₦300,000 (3%)

If B's downline Realtor C sold it:

- You earn ₦100,000 (1%)
